DESCRIPTION

This course is offered off site only (Perugia, Italy). It is part of the collaboration between the University of Calgary and the University of Foreigners in Perugia.

This is an intensive language class. It can only be taken in conjunction with ITAL 309. This course is taught entirely in Italian. Course load is 14 hours a week.

Prerequisite:

ITAL 201 and acceptance into the University of Calgary, Perugia program.
