DESCRIPTION

En este curso se presentará una introducción a la ficción y ensayística prosada que se ha escrito en lengua española desde la Edad Media hasta la actualidad. Se enseñará tanto el análisis literario de la prosa como la historia literaria.

Objetivos

Para una exitosa aprobación del curso los estudiantes habrán de demostrar:

- Conocimiento básico de la trayectoria narrativa de textos y movimientos literarios desde la Edad Media hasta la actualidad en España y Latino América.
- Habilidad para la lectura y la comprensión efectiva de textos claves de la prosa en español.
- Habilidad para expresarse y debatir efectivamente en español sobre conceptos y temas claves del contexto sociocultural, de la historia literaria y de la teoría de la narratología.

COURSE NOTES

Los dos exámenes parciales (50 minutos) son evaluaciones comprensivas que incluyen preguntas breves y ensayos cortos para demostrar un conocimiento de los textos, autores y movimientos estudiados. No habrá actividades suplementarias para complementar la nota.

Las dos presentaciones orales (5-10 minutos) serán exposiciones de una obra literaria y su autor. La participación es imprescindible en este curso, puesto que el debate y el trabajo en grupos pequeños contribuyen al desarrollo lingüístico y crítico. Se espera que la/el estudiante participe de una manera activa y voluntaria en la clase. No se puede sustituir el trabajo de clase por actividades suplementarias.

El profesor se reserva el derecho de sustraer el 10% de la nota final del curso si la/el estudiante no participa o no viene preparada/o a clases.

Los dos trabajos escritos (750 palabras cada uno) serán análisis de textos literarios. El ensayo final (2000 palabras) será un trabajo de investigación sobre un texto literario y se escribirá conforme a las normas bibliográficas de la MLA. Ya que se requiere investigación para el trabajo final, el/la estudiante consultará un mínimo de cinco fuentes secundarias de índole académica, las citará correctamente y evaluará su contenido a la vez que formulará su propia lectura de la obra literaria en cuestión.

- **Late assignments and missed tests policy:** Se aceptará la entrega de los trabajos tardíos sólo con el permiso del profesor. Se permitirá que se escriba los ensayos parciales después de la fecha que se anuncia en el calendario oficial del curso sólo en el caso de que se presente una nota de un médico.

- **Electronic submission of assignments:** Se acepta que los estudiantes entreguen los trabajos escritos por medio del correo electrónico en forma .RTF, .DOC, .DOCX o .PDF. No se acepta ningún otro formato para los trabajos.

ACADEMIC MISCONDUCT

1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:

- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.

4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
